#### **COURSE ASSIGNMENTS:**

#### I. Analysis of IOM Agendas for Nursing (25%)

The purpose of this assignment is to provide learners with the opportunity to become familiar with the IOM Agendas related to nursing. Students are expected to read and critique a variety of Institute of Medicine (IOM) reports. Learners are expected to select one area of interest from the IOM reports and write a **6 page double-spaced** comprehensive analysis of an agenda issue relevant to nursing practice or nursing education. The selected report must include at least two journal articles in nursing completed during the past 10 years related to the IOM agenda issue.

The IOM Paper should include the following:

- Introduction
- Discuss how the issue was framed or presented
- Discuss the importance of specific topic to nursing
- Identify the key stakeholders and positions held by each (pros vs. con?)
- Identify the power players (e.g., HCPs, consumer groups, patient groups, or community organizations) reported in the report or those from your specialty practice interest (e.g., well-child care, women's health, vulnerable populations in community settings, or the aging and elderly) that have an invested interest. Hint: the key stakeholders and power players may be stated in the journal articles.
- Discuss the key issues
- Discuss if there are conflicts among key values (e.g., social justice, beneficence, etc.)
- Discuss the implications of nursing practice and nursing education
- Discuss the supporting or opposing views from the journal articles in nursing
- Summarize the conclusions and recommendations
- References
- APA style, including organization, correct grammar and free of syntax errors
- All sources cited in the paper

## II. Taking Sides on a Controversial Issue (20%)

The purpose of this assignment is to allow learners an opportunity to become familiar with healthcare policy and defend a position on the selected policy.

- Choose a topic of interest to you in practice.
- Assume you are informing a group of policy-makers who are considering what to do about the issue. Write a 2-3 page paper that explain the issue and your position statement in support of the policy <u>OR</u> write a 2-3 page position statement in opposition to the policy.
  - The paper should include the rationale for your argument or why you chose your position. The position statement should persuade the reader that the position is correct.
  - Note which position you personally take and why.
  - Obtain and read at least four journal articles published in 2003 to present on the topic.
  - The position statements are NOT to be a summary of the articles but a position piece that uses elements of the research.

## III. Health Policy in Other Countries (15% presentation and 5% discussion)

The purpose of this assignment is to introduce learners to health policy and health care in countries other than the United States. The assignment will be delivered as a power point presentation.

• Each student will select a country from the following list:- UK, Brazil, Rwanda, Thailand, South Korea, Kuwait, Chile, China, Japan, Canada, Tanzania, Germany, France, Australia, Singapore, Sweden, Portugal, Spain, Denmark, South Africa, Saudi Arabia, Israel, Switzerland, Netherlands, New Zealand, Nigeria and Sierra Leone.

Note: Not more than one student can present the same country. It is first come first served!!

To avoid duplication, post your selection on the designated pilot discussion board by the Jan 20<sup>th</sup> at 11pm. Make sure you indicate your chosen country on the message "title" so that everyone can see your selection. For example: "Country by student name" – Denmark by Jane Jones

- Prepare a 15-20 power point slide presentation. This number of slides <u>excludes</u> the title slide and references.
- Post your final power point presentation on the assigned course **PILOT** discussion board.
- Select and review two peer presentations (*i.e. other than your own*).
- Briefly discuss how the health care systems in these countries are similar (compare) and different (contrast). Note: Cite references to support your opinions.
- Post your brief discussion response on the assigned pilot discussion board.
- Respond to one other posting. Note: Students will not earn a point by saying "I agree with that last comment".
- Overall quality and format: Make sure you follow the APA format in terms of grammar/spelling, use of appropriate and scholarly references in addition to text (e.g. professional/peer reviewed journals, internet .org/.edu are great but avoid Wikipedia, .coms.) and organization and flow of information.

<u>NOTE</u>: Grading rubric will be posted in PILOT to evaluate the presentations and discussion responses.

The purpose of this assignment is to analyze relevant health care issues and trends considering ethical, legal, economic, technologic and global implications in relation to currently proposed legislation. This is a group presentation (maximum of 3 randomly assigned students per group). Each group will evaluate a proposed piece of legislation and explore the possible effects on health and health care. While searching the literature, you will have the opportunity to examine health policy research.

Select a bill that has been introduced in the 112<sup>th</sup> Congress or the 129<sup>th</sup> Ohio General Assembly or the current legislature of another state and has <u>not</u> yet passed into law. Websites you may find useful in identifying proposed legislation include:

It is required that each group chose a different bill. Therefore, each group should search the web for either a bill being considered by the state of Ohio, another state or jurisdiction, or by the federal legislature. Once your group has chosen a bill, you must be sure no other group has claimed the bill. If no group has, your group may claim it. *To claim your bill, post the bill number on PILOT discussion board labeled* "Legislative Bills." Please indicate if the bill is a federal bill or a state bill (if it is state, please indicate the state). Please put the bill number, state or federal in the topic of the discussion.

An example of a posting in PILOT to "claim" your bill: "For Course NUR 7003, you are choosing U.S. Senate Bill 1185: Rural Provider Equity Act of 2003 Jane Doe." There are hundreds (literally) of bills related to health of our communities. Pick the one of most interest to you (as long as no other group has chosen it). Please post the bill your group plans to use not later than **March 12** (this is 3 weeks before the due date).

If you start working on a bill and your group decides you want to change to another bill, you are free to change bills at any time. The only restriction is that no other group has claimed the bill. So if your group gets tired of a bill or finds a better bill, feel free to change your focus. Please post the change, and e-mail the change to your faculty.

For your presentation, you are to analyze the bill from multiple perspectives. You need to expand the ideas inherent in that proposed legislation to the social problem/ issue/ debate that is the context for the legislation.

Legislative Bill Analysis Presentation Guidelines: The presentation should include the following:

- Present an overview of the issue, including brief historical background and current legislative initiatives including your example of a currently proposed legislation (can be either state or national).
- Refer to relevant health policy research and include at least 5 relevant scholarly sources, at least 2 to 3 of which must be research based.
- Analyze the factors/characteristics of the broader health care issue from multiple perspectives; including technological & global implications.
- Present an overview of the selected bill. This should be a summary of the bill in your own words.

- After the bill was introduced, discuss all actions that have been taken on the bill.
- Give the pros and cons of the proposed legislation.
- List the key sponsor(s) of the bill and briefly provide background information of each. Discuss their resources and base of support for this bill.
- Identify potential stakeholders of the issue. Who might be perceived as the beneficiaries of the bill? Explain why. Who might be perceived as being adversely affected by this bill? Explain why. Before writing this section, please refer to the class lecture and assigned readings on identifying and working with stakeholders
- Identify organized groups on either side of the proposed legislation. In other words, who would be considered "pro", "concerned neutral parties" and "con" and why.
- Analyze the economic impact of this issue and related policies.
- Analyze ethical concerns imbedded in the issue (*EXPLICITLY* reference an ethical framework or principles).
- Identify how the issue will impact health care and nursing practice.
- State and defend YOUR GROUP'S position on the bill and why?
- Identify possible resources and constraints that might support or inhibit the progress of the proposed legislation.
- Write a letter to a legislator about your position on the bill. This letter should be written as a formal business letter single spaced. If you agree with the legislator's position, thank the legislator and state why. If you disagree with his or her position, explain why.

# Note: Do NOT send this letter. It is just for educational purpose.

- References in APA 6<sup>th</sup> edition format.
- Each student should then select and review two legislative bills presentation (*i.e. other than your own*).
- Briefly discuss how they are similar (compare) and different (contrast). Note: Cite references to support your opinions.
- Post your brief discussion response on the assigned pilot discussion board.
- Respond to one other posting. Note: Students will not earn a point by saying "I agree with that last comment".

## NOTE: Grading rubric to evaluate your legislative bill analysis presentation will be posted in PILOT.

**V. Online Discussions Expectations and Instructions:** Learners are required to participate in 5 online discussions as part of their class participation. Details about each assignment will be posted in PILOT one the discussion board. Late submissions will be considered as "No class participation."

### **Expectations**:

- Each student should have at least the minimum postings to assigned discussions
- Required readings about the posting should be done before any discussion posting
- Cite references to back up opinions
- The response should show comments/ answers and/ or questions that are insightful, reflective or non-judgmental (i.e. use critical thinking approach).
- Students should avoid giving simple statements such as "I agree with the comment", "I agree with that last comment", "Yes, you are right".
- It is important that the students return to the discussion forum to read and respond to any questions raised by their peers.
